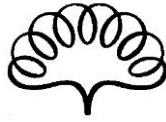

Notes of the Nomination Form

1. All members of the General Committee and every officer performing executive functions must be Malaysian citizens. Non-Malaysian citizens may hold such office as may be approved by the Registrar.

[Rule 49(ii)]

2. Nomination of all candidates for any post of office bearers of the Club shall be:-

(a) In writing;

(b) Accompanied by a statement from the candidate giving his consent to stand for election and declaring that he has not at any time within the immediate preceding thirty six (36) calendar months :-

(i) owed to the Club, for a period over ninety (90) days, any amount exceeding Ringgit One Thousand (RM1,000.00) AND

(ii) has not been placed on the Defaulters' List.

(c) Accompanied by a declaration that he has been an Ordinary Member of the Club for three (3) years prior to the date of the election.

(d) Signed by the proposer and seconder, both of whom must be Ordinary Members AND must not have at any time within the immediate preceding thirty six (36) calendar months

(i) owed to the club, for a period over ninety (90) days, any amount exceeding Ringgit One Thousand (RM1,000.00) AND

(ii) have not been placed on the Defaulters' List.

(e) Received by the Secretary at least fourteen (14) days before the date of the relevant General Meeting.

[Rule 60(i)]

3. Subject to these Rules, nominees of Corporate Members shall be entitled to be nominated as a candidate for any post as though he were an Individual Ordinary Member and if elected to remain an office-bearer so long as he remains as the nominee of such Corporate Member. A vacancy in the post shall be deemed to have occurred in the event that such person ceases to be the nominee of a Corporate Member unless such person is admitted as an Individual Ordinary Member of the Club or is appointed the nominee of another Corporate Member within thirty (30) days from his ceasing to be a nominee of the first mentioned Corporate Member.

4. Candidates must enclose two (2) passport size photographs with the nomination papers. The photographs will be displayed along with the nomination papers at the notice boards to identify the candidates vying for the respective office.

5. Incomplete and or defaced forms will be deemed as null and void and will be rejected outright.

The Nomination Form is available at the Reception Counter. The closing date to submit the nomination form is Saturday, 7th September 2024 at 11.59 pm (14 days before the date of the General Meeting).
